Therefore **Torni Automatici srl** aims to pursue all the means that are necessary to acheive the following aims, by individualising and evaluating the risks and the opportunities linked to the social, qualitative, environmental and safety context in which it operates:

- 1. Customer Satisfaction through:
- Communication with the customer in order to receive and correctly understand his/her necessities;
- Planning the company's procedures and methods to satisfy the customer's necessities;
- Incessant research for new technologies to make even more efficient and reliable the company's procedures;
- Involving, motivating and developing the human resources, valorising their professional growth at all levels, by sentitising and defining formation programs.
- 2. Environment protection and the tutelage of safety and health in the workplace by:
- Adopting all the possible measures to prevent any case of pollution;
- Promoting the conservation of the environment through activities that pursue the energetic saving and the sustainable use of resources;
- Softening the environmental impacts provoked by the company's activity, applying a correct garbage sorting and monitoring carefully its environmental context;
- Integrating the tutelage of safety and health in the workplace in every phase of the work process: planning the workplace (locations, equipements, machinery), stipulating works and services contracts, organising the productive process trough the division of tasks and responsibilities, and individuating the internal and external professional figures;
- The formation and training of the personnel to the observance of the normatives and procedures that concern the environment and the health and safety of workers;
- The collaboration and communication with the authorities in charge, in order to establish optimal conditions for the environment, the productive process, safety and health.
- 3. The observance of the principles of Social Accountability through:
- The transposition of the national and international legislations and normatives for what concerns the ethics (ILO and ONU resolutions and the United Nations Convention on the Rights of the Child), the Collective bargaining agreement of metalworkers, and the normative SA8000;
- The rejection of child labour exploitation and any form of forced or compulsory labour;
- The rejection of any form of discrimination and inequality in hiring, remuneration, access to training, promotion, termination or retirement based on race, religion, gender, sexual orientation, union membership, political opinions;
- The constant ameliorance of working conditions and actions that concern workers' safety and health;
- Involving in this system all the goods and services suppliers to which the company conforms, including the identification of potential risks of non-conformity to the normative, which have to be eliminated;
